As one of San Francisco's most anticipated developments, 2055 Chestnut Street sits in the heart of San Francisco's exciting Marina District. The project will consist of a three-story, mixeduse residential project featuring some of San Francisco's best new retail space. The lower level and ground floor retail spaces will feature 15-20 foot ceilings, loading capabilities, and an excellent opportunity for signage. With an anticipated delivery date of 2025, the 2055 Chestnut Street project will highlight what is already one of the busiest daytime and nighttime retail corridors in California.


